**BOARD MINUTES OCTOBER 21, 2024**

The October 21, 2024 meeting of the Board of Trustees for the Village of Elk Mound was called to order by Village President Terry Stamm at 6:00 p.m. in the Municipal Building. Karin Wolf, Clerk-Treasurer, verified that proper notice of the meeting had been posted.

Roll call showed Bob Bachman, Tim Benjamin, Pat Hahn, Pat Lien, Joyce Price and Terry Stamm present. Cynthia Abraham was absent.

**APPROVAL OF MINUTES**

Price/Hahn moved and seconded a motion to approve the Village Board minutes of September 16, 2024. Motion carried.

**CITIZEN’S FORUM – (PUBLIC INPUT):** Tom Gilbert expressed continued concerns regarding the addition of fluoride to the Village’s water supply. He asked the Village to consider stopping this process. John Nickolai stated that he also supports discontinuing the addition of fluoride to the Village’s water supply.

**PUBLIC APPEARANCE:** Paul Mahler, Bakke Norman, introduced himself as the new Village attorney. He is looking forward to working with the Village’s trustees and employees.

**APPROVAL OF GENERAL FUND AND WATER/SEWER UTILITY VOUCHERS :** Benjamin/Bachman moved and seconded a motion to approve the combined checks 33017-33057 and direct deposits V3806 – V3834 for a total of \$65,188.16. Motion carried.

**APPROVAL OF TID VOUCHERS:** There were no TID vouchers.

The Department responded to seven calls for service this month. The Department membership is currently 24 members.

Chief Fuester is working on ordinance changes for billing purposes. He is also working with their insurance company on updated replacement values for equipment. Engine 5 is still being repaired and painted as needed.

All of the second half assessments and 2% dues have been paid by the three municipalities. The second half of the year fire inspections will be conducted soon. A joint training with other Fire Departments was very successful.

Chief Fuester is recommending a banking switch to Independence State Bank. He is also currently working on the 2025 budget for the Department.

### **Report from Elk Mound/Colfax Solid Waste & Recycling**

The R.U. has completed the compensation adjustment effective for 2025. They are presently working on the 2025 per capita charges to the nine municipalities who are a part of the R.U. Work is continuing on the 2025 Colfax R.U. budget and they hope to have copies available soon.

### **Colfax Rescue Squad Monthly Report**

The Colfax Rescue Squad Monthly Report from August was reviewed and is on file in the Village Clerk/Treasurer's office.

### **Community Center/Library Report**

Terry Stamm reported that the Community Center/Library Board did not meet but is scheduled to meet on October 28 at 4:30 p.m.

President Terry Stamm reported that trick-or-treating will be held in the Village on October 31 from 5-7 p.m. The Lions Club will once again be handing out treats at the fire hall.

Lien/Hahn moved and seconded a motion to approve the following ordinance changes: in section 5-3-6(e), remove the words "or occupant" and in Section 1-3-1 fee schedule for Section 5-3-4, remove "not to exceed \$500" and the fee schedule for Section 5-3-6, change "location" to "property owner" and charge the following fees for police/fire false alarms: 1<sup>st</sup> – no charge, 2<sup>nd</sup> - \$250, 3<sup>rd</sup> - \$500, 4<sup>th</sup> - \$1,000. Motion carried.

### ORDINANCE REMINDER WINTER PARKING

**Per Sec. 10-1-29 (b) Winter Parking Restricted:**

- (1) No person shall park a vehicle on streets or portions of streets within the Village of Elk Mound, between the hours of 3:00 a.m. and 6:00 a.m., from November 1 through April 1, the snow removal season, except as follows:
  - a) On odd-numbered calendar days, on that side of the street with odd-numbered house numerals; and
  - b) On even-numbered calendar days, on that side of the street with even numbered house numerals.
- (2) In addition to the penalties of Section 10-1-50, Village officials may remove any such vehicle parked in violation of this Section to a place of storage and may charge the cost of towing and storage to the owner of such vehicle.

- 1. Location of Street Light (Nearest Address)
- 2. Nearest Cross Street
- 3. Issue (Blinking Light, Light Not Operating, etc.)

### ORDINANCE REMINDER

#### Sec. 6-2-8 Snow and Ice Removal.

- (a) **Removal From Sidewalks.** Within twenty-four (24) hours after the cessation of any fall of sleet or snow, it shall be the duty of the owners and/or the occupants of any lot or parcel of land in the Village of Elk Mound to remove, or cause to be removed, the snow or sleet from any and all sidewalks and the nearest cross-side-walks adjacent to the premises of such owner or occupant, and to keep the same free and clear of snow and ice for the full width of the sidewalk.
- (b) **Failure to Remove.** In case of failure or neglect of any owner or occupant of any land or parcel of land to remove the snow from sidewalks as specified in subsection (a) within the time set forth in said Subsection and, after twenty-four (24) hours after the cessation of any fall of snow, the owner or occupant has failed to remove such snow from sidewalks as specified in Subsection (a), the Public Works Department shall remove or cause the snow to be removed from any and all sidewalks and cross-sidewalks that may be so neglected by the owner or occupant, and a fee established by the Village Board shall be assessed against the owner or occupant for the cost and expense of moving such snow. The fee will be charged against the respective lots and parcels of land adjacent to which said work shall be done, as a special charge, and such sum or sums shall be collected in the same manner as other special taxes.

### ADOPT-A-HYDRANT PROGRAM

The Elk Mound Water Utility is asking residents and community businesses to adopt their neighborhood fire hydrants. They can do this by clearing accumulated snow around hydrants near their homes and places of employment.

Snow removal around the system fire hydrants is the responsibility of everyone, but during the winter storms, hydrants may become buried for sometime before utility crews reach all hydrants in the system.

Not all systems require utility personnel the sole responsibility to clear snow—but rely on street departments, fire departments and citizen volunteers. Please remember safety precautions must be followed. By taking a few minutes to clear your “adopted” hydrant, you’ll be assisting both the water and fire departments. The house you save might just be your own!

The following messages are courtesy of the U.S. Fire Administration:

Keep candles at least 12 inches away from anything that burns. Make sure they are in stable holders and place them where they cannot be knocked down easily.

Inspect holiday lights each year before you put them up. Throw away light strands with frayed or pinched wires.

Water your Christmas tree every day. A dry Christmas tree can burn very hot and very fast.

Have a safe and happy holiday season!

**Put a FREEZE on Winter Holiday Fires**

**Did you know?** More than 1 in every 5 Christmas tree fires were caused by a heat source too close to the tree.

**As you deck the halls this season, be fire smart.**

- Read manufacturer's instructions for the number of light strands to connect.
- Make sure your tree is at least 3 feet away from heat sources like fireplaces, radiators and space heaters.

### WARNING SIREN

When severe weather occurs, you will hear a steady tone for three minutes. Upon early warning, volunteers will attempt to set the Warning Siren to a STEADY TONE. This warning is to inform you to seek information from TV, broadcast radio, or "NOAA Weather Alert" radio. For residents that do not have adequate shelter, the Lutheran Church, 207 University Street, has offered the use of the church basement. Every effort will be made to get the rear (south) doors opened on alarm. **YOU SHOULD MAKE ALTERNATE PLANS IN THE EVENT THE CHURCH IS NOT OPEN!!**

Having a plan in place will minimize confusion when time is of the essence. Preplanning to bring flashlights, possibly a blanket, as well as making other arrangements for pets will make for quick access to shelter. (Please do not bring pets to the Church).

***This plan will be in effect immediately and until further notice.***

"NOAA Weather Alert" radios are available for purchase at local electronics or major department stores. These units can be used in addition to the local warning siren for early severe storm alerts.

According to Dunn County Emergency Management, the siren is intended to alert people outdoors that severe weather conditions are nearby. The sounding of these sirens is your cue to access local detailed weather information from radio or television and discover if there is an need to take further action. More information can be found on their site: [www.dunn.wi.co.us](http://www.dunn.wi.co.us), click on Departments, Emergency Management & Outdoor Warning Sirens.

Dunn County Communications Center is responsible for testing the emergency siren system April through October. Village of Elk Mound tests November through March. The Emergency Warning Siren is tested the first Monday of each month at 10:00 am and monitored by the Village of Elk Mound. Standard emergency warning siren electro-mechanical tones are as follows:

- ALERT— Steady Tone, 3 minutes
- ATTACK—Wailing Tone, 6 sec. Hi/6 sec. Low, 3 min
- FIRE— Wailing Tone, 16 sec. Hi/8 Sec. Low, 4 Cycles
- GROWL— Short Burst, 2 Sec. Used for testing of siren only.

- February 3, 2024
